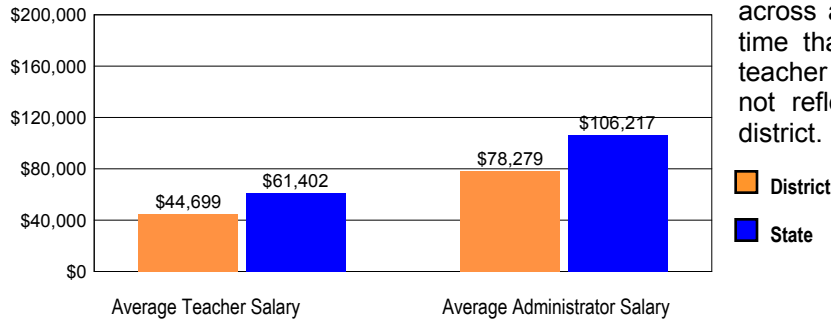

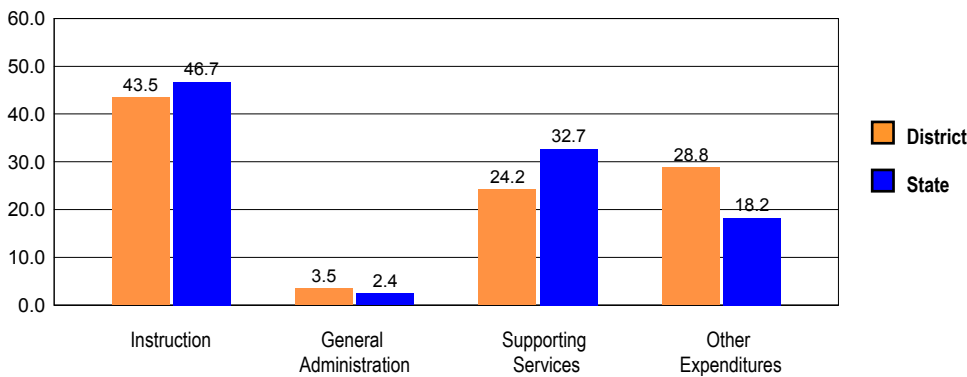
## SCHOOL DISTRICT FINANCES

### EXPENDITURE BY FUNCTION 2007-08 (Percentages)



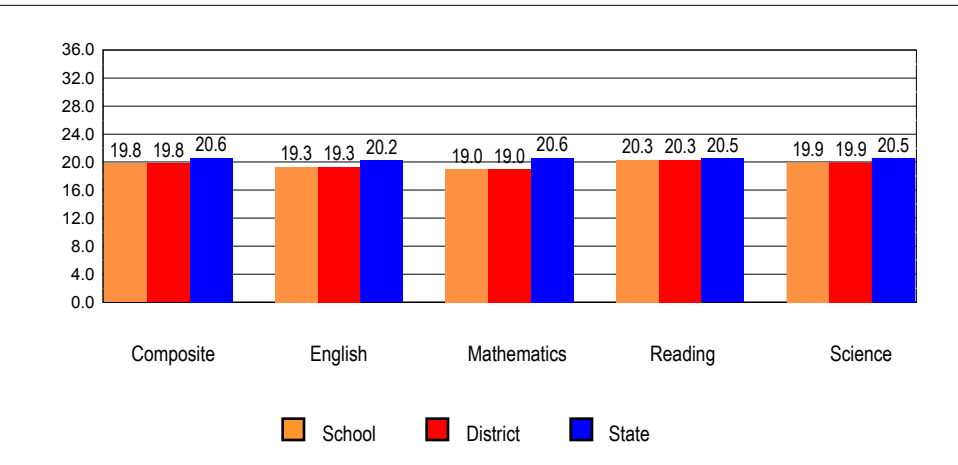

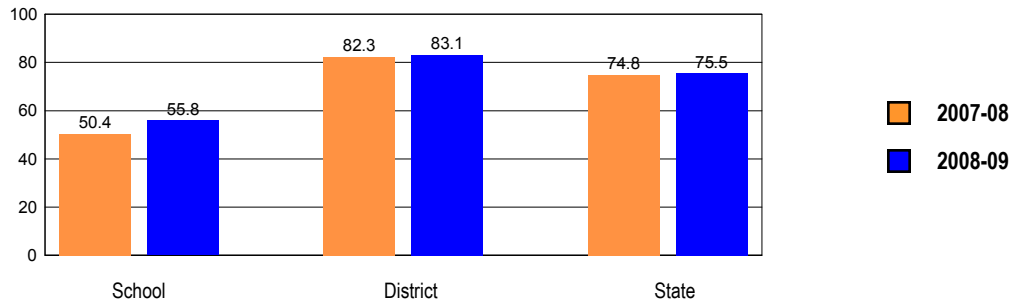

## OVERALL STUDENT PERFORMANCE

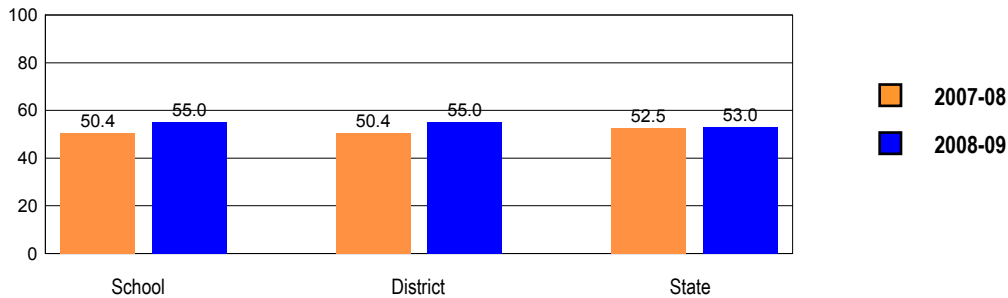

### OVERALL PERFORMANCE - ALL STATE TESTS

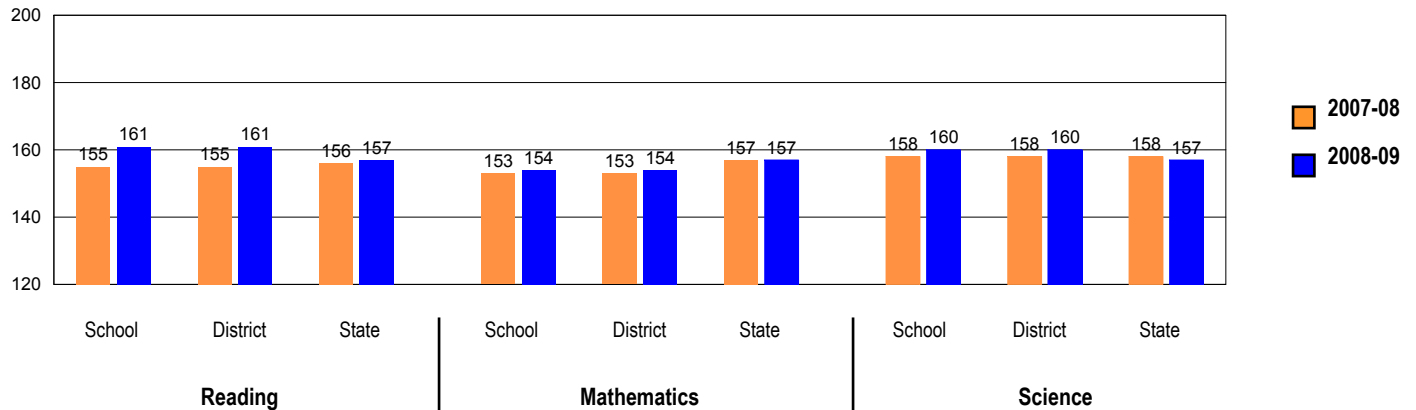


### OVERALL PRAIRIE STATE ACHIEVEMENT EXAMINATION (PSAE) PERFORMANCE

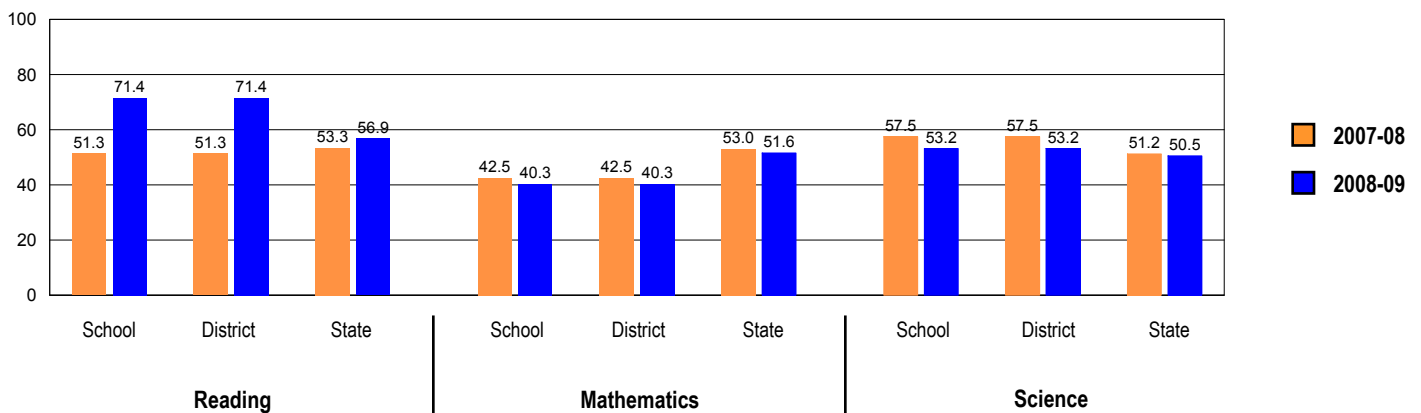


**PSAE PERFORMANCE**

**PERFORMANCE ON STATE ASSESSMENTS**

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

**PRAIRIE STATE ACHIEVEMENT EXAMINATION (PSAE)**

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

**Four Conditions Are Required For Making Adequate Yearly Progress (AYP):**

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

\*\* Safe Harbor Targets of 70.0% or above are not printed.

\*\*\* Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

**PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT****Areas of Success:**

The results of best practices are evidenced throughout our learning community. Implementation of the RtI program at high school level continues to address concerns for students who are at “at risk”.

The core curriculum at for reading and math continues to be a focus of attention with effective practice for all students, including all-school reading & writing instruction with graphic organizers, and professional development help from the Regional Office of Education with Standards Aligned Classrooms (SAC) within the math department.

As evidenced by our PSAE scores, high school students improved dramatically in reading and writing, increasing scores by more than 22 percentage points. Writing instruction will continue to be a focal point for the coming year..

Our ACT composite score is 19.9, very close to the 20.0 state average, and rising above last year’s 19.1.

**Areas of Concern and Planned Improvements:**

We will continue our area of focus for writing & reading improvement. All high school staff will include frequent reading and writing exercises, including the use of advanced graphic organizers to help students increase gaps in achievement.

Our Math PSAE scores continue to fall well below expectations (41.8%). Efforts are underway to closely examine our core curriculum and revise introductory course content and sequence in order to better serve the students.

We continue to focus on our “at risk” students through the use of RtI intervention groups through our Study Skills class. Students receive Tiered intervention throughout the day in the areas of math and reading. Our goal is that all students will meet and/or exceed and until that mark is met we will strive to increase student achievement yearly.

Best teaching practices continue to be a professional development goal for our staff. Marzano and Associates will be conducting an in-service for the entire district and staff will be focused on “The Art and Science of Teaching” during a year-long book study. The other two areas of professional development that the staff will focus on are Differentiation and Strategic

Instructional Model. It is our goal to provide the latest research based instructional strategies to all Dee-Mack instructional leaders.
